
The main aims and objectives of the Trust are as follows:

c. Establishment and /or-acquisition and maintains of support of schools, colleges, institution, libraries, reading, rooms, museums, vidyapiths, balmandirs.




15. In addition to powers conferred on them and without detracting from the generality there of, the Board of trustees shall have the following powers:







19. The trustees have authorized to invite or accept donations of money, share debentures, bonds, securities, business and other movable or immovable property from the legacy as think fit.


